# WRC now Largest Private Landowner on Hoh River!

MORE CRITICAL FISH HABITAT ACQUIRED The Hoh River on Washington's Olympic Peninsula is a legendary salmon stream and one of Western Rivers Conservancy's top priorities. As part of our ongoing effort to create a Hoh River conservation corridor from headwaters to estuary, WRC recently purchased another group of properties critical to the Hoh River ecosystem. With this recent purchase, WRC is now the largest private landowner on the river! WRC owns over ten miles of the Hoh, which is a third of the way to achieving our

vision of a thirty-mile-long Hoh River conservation corridor.

The acquired property includes two miles of frontage along the mainstem Hoh, three miles along both sides of Nolan Creek and portions of lower Braden Creek and Pins Creek. Protection of the lower three miles of Nolan Creek, including the stream's mouth, safeguards one of the Hoh basin's most important cohoand steelhead-producing streams. Nolan Creek, which is often tea-colored with tannins from the surrounding forest, is the only tannic stream on the Olympic Peninsula known to contain bull trout. Both Braden and Pins Creeks are also important fish-producing tributaries to the Hoh River.

With our partner, the Wild Salmon Center, Western Rivers Conservancy is working to protect Hoh River lands between the *Continued, page 3* 



# Goose Creek Project Gets a Major Boost

#### Our Largest Project to Date

In January, our initiative to buy the largest tributary to California's legendary Smith River got a big boost when the current administration budgeted \$2 million for the project.

In Western Rivers Conservancy's biggest project to date, we have made a deal with Simpson Timber Company to buy their entire ownership of 9,438 acres in the watershed of Goose Creek, the biggest tributary to California's healthiest wild salmon stream, the Smith. ## Treasured Whitewater Run Protected

#### SANDY'S INNER GORGE IN PUBLIC HANDS

With another terrific accomplishment on the Sandy River, WRC has protected the Sandy's famed "Inner Gorge," a favorite expert kayaking run. With a generous donation of 304 acres from Portland General Electric (PGE), WRC was able to complete the protection of this treasure in Portland's backyard.

To cap this achievement, WRC was able to secure permanent boater access to this exceptional run. PGE donated another 117 acres above the Inner Gorge along Marmot Road, which guarantees public access to the Inner Gorge put-in.

The Inner Gorge is a five-mile-long basalt canyon with waterfalls, seeps, cliff-dwelling plants and old growth forest. There are four class IV rapids in this five mile reach, making it one of the most challenging runs in the greater Portland area. In addition, the 304acre property donated by PGE contains the largest block of mature forest along the middle Sandy.

WRC is partnering with PGE and the Bureau of Land Management to remove two dams from the Sandy River basin and create an eleven-mile-long conservation corridor along the middle Sandy. To date, WRC has acquired and protected 2,191 acres of land in the Sandy River basin.

## WRC Opens California Office, Staffed by Russ Pinto

#### California Campaign

Western Rivers Conservancy is doing more and more river protection work in California. Our Big Chico Creek project established a 4,000-acre preserve along five miles of Big Chico Creek, now managed by California State University, Chico. Our Goose Creek project on the Smith River is our first initiative in California's north coast region.

In February, we took the exciting step of opening our California office in Sebastopol, north of San Francisco. The office, at 313 North Main Street, will be led by new staff member Russ Pinto. Russ has more than 20 years of experience in conservation land-buying, beginning in the Wood River Valley of Idaho. Later he worked with the Trust for Public Land for 3 years, focusing on the Columbia River Gorge. For the past 14 years Russ has been the Director of Land Protection for The Nature Conservancy in Oregon, serving as their chief negotiator on all real estate transactions, public and private. Russ has dedicated his career to ecosystem protection, working with a wide range of partners. He sees his new position with WRC as a chance to protect outstanding rivers throughout the Sierra Nevada, the redwood coast, the Central Valley and other beautiful regions of California.

## Little Sandy Almost Entirely Protected

RESTORING A ONCE-GREAT STEELHEAD STREAM



Dam removal will make the Little Sandy River free-flowing for the first time in more than ninety years.

The sixteen-mile-long Little Sandy River is nearly all protected and in public ownership. In 2003, WRC acquired 200 acres of land in two parcels along the Little Sandy. Only four miles of the Little Sandy's course are not protected in public ownership, and these purchases include over two miles of that reach. WRC also secured a donation of 100 acres this year from PGE along the Little Sandy, bringing WRC close to protecting the entire corridor.

The Little Sandy was once a blue-ribbon steelhead stream but has been cut off from its mouth by water diversions since 1907. Removing the dam will allow fish to access ten miles of high-quality habitat. The Little Sandy has pristine forested headwaters on the west slope of Mt. Hood, a robust riparian plant community, low sediment loading, low water temperature and ideal aquatic habitats. Dam removal coupled with land protection will give Little Sandy steelhead the best possible opportunity to recover.

Olympic National Park boundary and the Pacific Ocean. Creation of this thirty-mile-long conservation corridor will safeguard one of the finest salmon and steelhead streams remaining in the continental United States. WRC will convey all of the land purchased on the Hoh to the Hoh River Trust, a nonprofit organization that we are forming with the Wild Salmon Center. The Hoh River Trust will be an organization dedicated to long-term conservation stewardship and public access to the river.

existing Smith River National Recreation Area, we will protect against future logging and road-building that could jeopardize the crystalline water quality of

the Smith. We are working closely with the Smith River Alliance and California Trout on this project.

The administration budget lineitem for Goose Creek enables the Forest Service to begin working with us to acquire the Goose Creek lands. In a round of meetings over the past few months, local Congressman Mike Thompson and Senator Dianne Feinstein have taken the lead in seeking funding for the project in the Congressional appropriations process. The Del Norte County Board of Supervisors has written a letter to support the project, while citing their concerns over loss of county tax revenues.

Our work on this project has been made possible by grants from the Heller Charitable Foundation, Weeden Foundation, Goldman Fund and the Compton Foundation and a grant and loan from the Resources Legacy Fund Foundation.

#### A Life-Long Investor in Rivers

Growing up with a Cascade stream in his backyard, Gwestern Rivers Conservancy's founding Board Member, Norb Wellman, developed a love for rivers at an early age. Butte Creek ran through his family's Mount Angel, OR farm, and Norb often fished there for trout and steelhead and swam the creek's waters. Over time, he saw those clear waters turn silty and degraded — an experience that stuck with him. Years later, a mutual friend introduced Norb to WRC President Phil Wallin, and they struck an accord that was the beginning of a partnership in conservation.

"Norb was the first person we turned to when we founded Western Rivers Conservancy," Phil Wallin says. "He epitomizes the Westerner who loves rivers, has gotten a lot of enjoyment from rivers and wants to give something back. Norb is the rock that Western Rivers was founded upon."

Norb is the founding partner of the investment firm Ferguson Wellman Capital Management Inc., located in Portland. An Oregonian to the bone, he went to Oregon State University on a baseball scholarship, where he pitched the Beavers to the College World Series in 1952. After *Continued, back page*
